O R D E R

1. The petitioner before us prays for transfer of the case being Civil Suit (Commercial Division) No.226 of 2024 titled "Mr. V.G. Maariappan Sole Proprietor M/s. Vinayaga Communication vs. Nishant Ujjwal and Ors." pending before the High Court of Judicature at Madras to the High Court of Judicature at Bombay.
2. The suit has something to do with infringement of copy rights.
3. The transfer is essentially prayed for on the ground that the petitioner instituted a Suit first in point of time in the High Court of Judicature at Bombay with respect to the very same subject matter and dispute.
4. In such circumstances, the petitioner prays that let both the Suits be consolidated and be tried by the High Court of Judicature at Bombay.

5. Having heard the learned counsel appearing for the parties and having tried to understand the nature of dispute, we are of the view that the parties should try to resolve the dispute amicably.

6. For this purpose, we direct the parties to appear before the Supreme Court Mediation Centre on 01.12.2025.

7. Once we receive the Report of the Mediator, we shall proceed further with the matter.

8. In the meantime, the further proceedings of IP Commercial Suit No.175/2023 pending in the High Court of Judicature at Bombay as well as the CS Commercial Division No.226/2024 pending in the High Court at Madras shall remain stayed.

9. List the matter immediately after a Report is received from the Mediation Centre.
