ITEM NO.1 - SLP (C) Nos.16721-16722/2019

These Special Leave Petitions challenge the final judgment and order dated 12.10.2018 passed by the High Court of Kerala at Ernakulam in Writ Petition (C) No.602 of 2015 and Writ Petition (C) No.13120 of 2015.

Special Leave Petition Diary No.9610 of 2019 arising out of the same judgment and order had come up before the Bench of Hon'ble the Chief Justice, Hon'ble Mr. Justice Deepak Gupta and Hon'ble Mr. Justice Sanjiv Khanna, and was dismissed on 01.04.2019. It appears that Review Petition (Civil) Nos.1430-1431 of 2019 arising from said order of dismissal are still pending consideration.

By order dated 12.07.2019, the instant Special Leave Petitions were directed to be listed alongwith Review Petition (Civil) Nos.1430-1431 of 2019 in open Court, by the Bench comprising Hon'ble the Chief Justice, Hon'ble Mr. Justice Deepak Gupta and Hon'ble Mr. Justice Aniruddha Bose.

In the circumstances, since the instant Special Leave Petitions are directed to be listed alongwith Review Petitions, the Registry is directed to take requisite directions from the Hon'ble the Chief Justice of India for listing of these Special Leave Petitions alongwith connected matters before the appropriate Court on 29.01.2021.
