UPON hearing the counsel the Court made the following
O R D E R

W.P. (C) No.69/2018

Service is complete on respondent No.1. Four weeks' time, as last opportunity, is granted to the Ld. Advocate, Mr.Vibhu Shanker Mishra, appearing on behalf of Ms. Anil Katiyar, Advocate-on-record for filing vakalatnama and counter affidavit on behalf of respondent No.1.

The Ld. Counsel for the petitioner submitted that proof of pleadings upon respondent No.2 has been served but the Ld. Counsel for respondent No.2 submitted that he has received the copy of pleadings only on 17.9.2018 and sought time to file counter affidavit. Four weeks' time is granted for filing counter affidavit.

Respondent Nos.3 and 4 have already filed counter affidavit. The Ld. Counsel for the petitioner submitted that he has not received copy of the counter affidavit filed by respondent No.4. Be served within one week.
