UPON hearing the counsel the Court made the following
O R D E R

W.P.(C) No. 69/2018

In the said petition, the Ld. Counsel for the petitioner submitted that service is already complete qua all the respondents. Respondent Nos.3 and 4 have filed counter affidavit. Three weeks' time has already been granted by the Hon'ble Court to respondent No.2 for filing counter affidavit. No counter affidavit has been filed by them. The Ld. Counsel requested that the matter may be listed before the Hon'ble Court.

However, the Ld. Counsel for respondent No.2 in this matter submitted that he did not appear on the date of the passing such order. He has filed vakalatnama only on 6.7.2018.

He further submitted that complete set of pleadings has yet not been served upon him. The Ld. Counsel for the petitioner is directed to serve complete set of pleadings within one week and file proof thereof. The Ld. Counsel for respondent No.2 to file counter affidavit within four weeks thereafter.

Service is complete on respondent No.1. The Ld. Advocate, Mr. Deepak Tyagi, appearing on behalf of Ms. Anil Katiyar, Advocate-on-record appears for respondent No.1. He seeks time to file vakalatnama and counter affidavit. Be filed within four weeks.

W.P.(C) No.118/2018

Last and final opportunity is granted to respondent No.1 for filing counter affidavit within four weeks.

Respondent No.2 has not filed counter affidavit, despite last and final opportunity having been granted. Further opportunity is declined.

W.P.(C) No.141/2018

Service is complete on respondent No.1 but none has entered appearance.

One week's time, as last opportunity, is granted to the Ld. Counsel for the petitioner for serving copy of complete set of pleadings upon respondent No.2 and file proof thereof. Counter affidavit be filed within four weeks thereafter.

Respondent Nos.3 and 4 have not filed counter affidavit, despite last and final opportunity. Further opportunity is declined.

W.P. (C) No.233/2018

Service is complete on respondent No.1 but none has entered appearance.

Four weeks' time, as last opportunity, is granted to respondent Nos.2 to 9 for filing counter affidavit.

W.P. (C) No. 250/2018

Service is complete on respondent No.1. Four weeks' time is granted to the Ld. Advocate, Ms. Nishaka Tyagi, appearing on behalf of Mr.Shashi Bhushan, Advocate-on-record for filing vakalatnama and counter affidavit on behalf of respondent No.1.

Service is complete on respondent Nos.4 and 5 but none has entered appearance.

Last and final opportunity is granted to respondent Nos.2 and 3 for filing counter affidavit within four weeks.

W.P. (C) No. 466/2018

Service is complete on respondent No.1 but none has entered appearance.

Four weeks' time is granted to respondent Nos.2 to 4 for filing counter affidavit.

W.P. (C) Nos.380, 406,368,393,395,371,374,372,385,367,360 and 369 2018

Service is complete on respondent Nos.4, 5, 7 to 9 and 11 to 13. Four weeks' time, as last opportunity, is granted to the Ld. Advocate, Mr. Rajat Kapoor, appearing on behalf of Mr.Anis Ahmad Khan, Advocate-on-record for filing vakalatnama and counter affidavit on behalf of the said respondents.

The Ld. Advocate, appearing on behalf of Mr. Mushtaq Ahmad, Advocate-on-record appears for respondent Nos.2 and 3 in W.P.(C) Nos.360 and 372/2018. He seeks time to file vakalatnama and counter affidavit. Be filed within four weeks. The Ld. Counsel for respondent Nos.2 and 3 submitted that complete set of pleadings has not been served. The Ld. Counsel for the petitioner is directed to serve complete set of pleadings within one week after filing vakalatnama and file proof thereof. Period of four weeks for filing counter affidavit shall reckon thereafter. Service is complete on respondent Nos.2 and 3.

Last and final opportunity is granted to respondent No.10 (common in all the matters except W.P.(C) No.360/2018) for filing counter affidavit within four weeks.

Rest of the respondents have been served but no one has entered appearance.

W.P.(C) No. 411/2018

Four weeks' time is granted to respondent No.1 for filing counter affidavit.

Service is complete on respondent Nos.2 and 3 but none has entered appearance.

W.P.(C) No. 594/2018

Service is complete on respondent Nos.4 and 5. The Ld. Advocate, appearing on behalf of Mr. Syed Jafar Alam, Advocate-on-record appears for respondent Nos.4 and 5. He seeks time to file vakalatnama and counter affidavit. Be filed within four weeks.

Service is complete on respondent Nos.2 and 3. The Ld. Advocate-on-record, Mr. Siddharth appears for respondent Nos.2 and 3. He seeks time to file vakalatnama and counter affidavit. Be filed within four weeks.

The Ld. Advocate, Mr. Rahul Kaushik appears for respondent No.4. He seeks time to file vakalatnama and counter affidavit. Be filed within four weeks.
