UPON hearing the counsel the Court made the following  
O R D E RW.P.(C) No. 118/2018

The Id. Counsel for respondent No.1 submits that he has not received the complete set of pleadings. The Id. Counsel for the petitioner is directed to serve complete set of

pleadings with proof of service of pleadings upon the Ld. Counsel for respondent No.1 within one week, as last opportunity. Counter affidavit be filed within four weeks thereafter.
