Delay in filing for substitution is condoned.

Abatement is set aside.

Application(s) for substitution are allowed.

Learned senior counsel appearing for the respondents submitted that they do not wish to contest the matter on merits and, therefore, there is no need for remitting it to the High Court for fresh consideration, particularly, in view of the law laid down in the case of *Deepak Aggarwal and Ors. (supra)*. It is further submitted that the compensation as awarded by the learned District Collector may be permitted to be withdrawn.

In view of the submission made, the amount is directed to be disbursed to the respondents within a period of 12 weeks.

The appeals stand disposed of.

In view of the decision rendered in *The State of Haryana & Ors. v. Krishan Kumar & Ors.*- Civil Appeal No.6124/2022 dated 20th February, 2023, the impugned order stands set aside. However, we are not willing to remit the matters back to the High Court for fresh consideration on the other issues, in view of the statement made by learned counsel for the appellant that they have already withdrawn the compensation and therefore, would not like to contest the matter on merits even before the High Court with respect to acquisition.

The appeal stands allowed.

Application(s) for deletion and addition are also allowed.

Application(s) for impleadment are allowed.

The issues involved with respect to initiation of the proceedings under the Land Acquisition Act has been decided by this Court in *Deepak Aggarwal and Ors.* Taking into consideration the said decision, this Court in *Krishan Kumar and Ors. (Supra)* was pleased to pass the following order:

“It reveals from the record that apart from the question raised regarding the scope and ambit of Section 24(1) of the Act, 2013 in reference to the trigger point in regard to initiation of the acquisition proceedings under the Act, 1894 other questions raised are left open to be examined by the High Court.

In the light of the judgment of this Court of which reference has been made, at

least the question which was decided under the impugned judgment by the High Court dated 05.09.2017 does not hold good and deserves to be set aside.

The appeal succeeds and accordingly allowed. The judgment of the High Court dated 05.09.2017 is hereby quashed and set aside. All other issues are left open for the parties to raise before the High Court."

In view of the aforesaid order, all these appeals are allowed with particular reference to the issue decided alone.

Accordingly, the impugned orders are set aside and the matters are remitted to the High Court for fresh consideration of all the other issues on merits that have been raised in the respective petitions in accordance with law.

Taking into consideration the long pendency of the proceedings, coupled with the subsequent developments that have occurred, we request the High Court to make an endeavour to decide all these matters within a period of six months from the date of the receipt of this order.

The appeals are allowed.

In the meanwhile, *status quo* with regard to possession as of today shall be maintained.
