that the lands are similarly situated and will pass orders accordingly.

The main contention of the petitioners is that their lands are similarly situated as those covered by C.A. No. 1077/2015.

The respondents are directed to file an affidavit, within three weeks, as to whether the submission is correct or not. If it is not correct, the extent of difference shall also be indicated in the affidavit.

It is made clear that in case the required affidavit, mentioning therein the difference, if any, is not filed within the time granted the Court will be constrained to have a decision that the lands are similarly situated and will pass orders accordingly.
