Transfer Petition (Crl.) No. 134 of 2014 has been filed under Article 139-A of the Constitution of India for transfer of Case No.310/IX/2014 titled 'Rekha Sharma Vs. Mukesh Dixit' pending before the Judicial Magistrate Second Mathura, U.P. to appropriate Family Court, Patiala House at Delhi.

Transfer Petition (Crl.) No. 137/2014 has been filed under section 406 Crl. P.C. for transfer of Case No.45/2013 titled 'Rekha Sharma Vs. Mukesh Dixit' pending before the Judicial Magistrate Second Mathura, U.P. to appropriate Court, Patiala House at Delhi.

Thereafter Transfer Petition (Crl.) No. 138/2014 has been filed under section 406 Crl. P.C. for transfer of Complaint Case No. 325/2012 titled 'Rekha Sharma Vs. Mukesh Dixit & Ors.' pending before the Judicial Magistrate First Mathura, U.P. to appropriate Court, Patiala House at Delhi.

On notice the respondent has appeared.

The learned counsel appearing on behalf of respondent submits that he has no objection if all the cases are transferred. However, according to him in spite of interim order passed by this Court certain orders passed by the Court below.

Having heard the learned counsel for the parties, we allow the prayers and transfer Case No.310/IX/2014 and No.45/2013 titled 'Rekha Sharma Vs. Mukesh Dixit' pending before the Judicial Magistrate Second Mathura, U.P. to Family Court, Patiala House at Delhi and transfer Case No.325/2012 titled 'Rekha Sharma Vs. Mukesh Dixit & Ors.' pending before the Judicial Magistrate First Mathura, U.P. to Family Court, Patiala House at Delhi.

Transfer petitions are allowed and disposed of with the aforesaid observations and directions.

Respondents are given liberty to challenge the order, if any passed after interim order passed by this Court, before a Court of Competent Jurisdiction.

Contempt Petition ( C ) No. of 2014

In view of the order passed in the transfer petitions, the learned counsel for the petitioner sought permission to withdraw the contempt petitions. Accordingly, the contempt petitions titled Mukesh Dixit & Ors. Vs. Rekha Sharma & Anr. (unregistered) are disposed of as withdrawn.
