OFFICE REPORT

"SLP(C) No.7598-7599/2015

Ld.counsel for the petitioner is directed to take fresh steps in respect of the respondent Nos.14 & 23 within four weeks.

SLP(C) No. 28464-28466/2015

Await the return of the service of notice already issued to the sole respondent in SLP(C) No.28464/15.

SLP(C) No. 29618-29621/2015

Ld.counsel for the petitioner shall within a period of four weeks file the fresh particulars of the respondent No.36 in SLP(C) No.29620/15 and he shall also take fresh steps for the service of notice to him within the same period.

Await the return of the service of notice already issued to the other unserved respondents.

List the matters again on 22.09.2016.

SLP(C) No. 28837/2015

Ld.counsel for the petitioner has failed to take fresh steps in the respect of the respondent Nos.1-5 despite opportunities given. Therefore, the matter shall be processed for listing before the Hon'ble Judge in Chambers for further directions. Await orders and list thereafter."

SLP(C) Nos. 7598-99/2015:-

It is submitted that there are 23 respondents. Counsel appearing for respondent Nos. 1 to 13 & 15 to 22 has already filed counter affidavit. A.D. card duly signed by respondent

No. 23 has already been received but no one has entered appearance. Fresh notice to respondent No. 14 was issued on 29.08.2016 by regd. A.D. As per India Post Tracking report the same has been delivered (copy enclosed) but no one has entered appearance.
