SLP(C) No. 28464-28466/2015

Fresh steps for the service of notice by usual mode to the sole respondent in SLP(C) No. 28464/2015 shall be taken by the learned counsel for the petitioners within a period of four weeks.

SLP(C) No. 29618/2015

Fresh steps for the service of notice by usual mode to the sole respondent Nos. 3 to 5, 8 and 9 shall be taken by the learned counsel for the petitioners within a period of four weeks, as last chance.

SLP(C) No. 29619/2015

Fresh steps for the service of notice by usual mode to the sole respondent Nos. 1, 3 and 6 shall be taken by the learned counsel for the petitioners within a period of four weeks, as last chance.

SLP(C) No. 29620/2015

Four weeks time, as last chance is given to the learned counsel for the petitioners to comply with the terms of the order dated 5.4.2016 of this Court in respect of the unserved respondents.

SLP(C) No. 29621/2015

Fresh steps for the service of notice by usual mode to the sole respondent Nos. 1,2, 7 to 9, 13 to 17, 19 to 21 and 23 shall be taken by the learned counsel for the petitioners within a period of four weeks, as last chance.

SLP(C) No. 28837/2015

Fresh steps for the service of notice by usual mode to the sole respondent Nos. 1 and 5 shall be taken by the learned counsel for the petitioners within a period of four weeks, as last chance.

SLP(C) Nos. 7598-99/2015:-

It is submitted that Mr. Balraj Dewan, Advocate has filed vakalatnama/appearance as well as counter affidavit on behalf of all the respondents except respondent Nos. 14 & 23. vakalatnama/appearance on behalf of respondent Nos. 14 & 23 is still awaited.

SLP(C) Nos. 28464-66/2015:-

It is submitted that fresh notice to sole respondent in SLP(C) No. 28464/2015 was issued on 02.08.2016. Service is awaited. Service is already complete on sole respondent in SLP(C) No. 28464 & 28465/2015 but no one has entered appearance so far.

SLP(C) No. 29618/2015:-

It is submitted that fresh notice to unserved respondents was issued on 08.08.2016 to respondents Nos. 3-5, 8, 9 in SLP(C) No. 29618/2015, respondent Nos. 1, 3, 6 in SLP(C) No. 29619.2015, respondent Nos. 1, 2, 7, 9, 12-14, 20, 22, 24, 30, 33-35 in SLP(C) No. 29620/2015 and respondent Nos. 1, 2, 7-9, 13-17, 19-21, 23 in SLP(C) No. 29621/2015. Counsel for the petitioner has not filed fresh particulars of respondent No. 36 in SLP(C) No. 29620/2015 so far, hence fresh notice is yet to be issued.

Service is not complete.

SLP(C) No. 28837/2015:-

It is submitted that counsel for the petitioner has not taken fresh steps to serve respondent Nos. 1 to 5 so far.

Service is not complete on respondent Nos. 1 to 5.
