Service position of each matter is given bellow:-

SLP (C) NOS. 28464-28466/2015

It is submitted that neither AD card nor unserved cover containing notice to sole respondent in SLP (C) No. 28464/2015 has been received. Service is already complete on sole respondent in SLP (C) Nos. 28465-28466/2015 but no one has entered appearance so far.

Service is not complete on sole respondent in SLP (C) No. 28464/2015.

SLP (C) NOS. 29618/2015

It is submitted that there are 10 respondents in this matter. Neither AD cards nor unserved cover containing notice to Respondent nos. 3, 5, 8 & 9 has been received.
