OFFICE REPORT

The matters above mentioned were listed before the Hon'ble Court on 19.02.2016 when the Court was pleased to pass the following Order:-

"SLP(C) Nos. 21475-21487/2010

Await the return of the service of notice already issued to the respondent No.34.

The office report indicates that although by order dated 15.12.2015 of this Court four weeks time as last chance was given to the Learned Counsel for the petitioners to comply with the terms of the order dated 30.9.2015 in respect of the deceased respondent No. 206, yet he has not done the needful within the period stipulated in the order. Viewed in that context, the matter shall be processed for listing before the Hon'ble Judge in Chambers for further future directions. Await orders. List thereafter.

SLP(C) No. 17555/2013

The Ld. Counsel for all the respondents have failed to file the counter affidavit within the period stipulated under the rules. Viewed, in that context, the matter shall be processed for listing before the Hon'ble Court, under the rules.

SLP(C) No. 7598-7599/2015

The office report indicates that Learned Counsel for the petitioners has taken the fresh steps on behalf of the Respondent No.14 but failed to file the fresh address despite order dated 15.12.2015. Viewed in that context, the matter shall be processed for listing before the Hon'ble Judge in Chambers for further future directions. Await orders. List thereafter."

SLP(C) Nos. 21475-87/2010:-

It is submitted that A.D. card duly signed from respondent No. 34 in SLP(C) No. 21475/2010 has been received but no one has entered appearance so far.

It is further submitted that Hon'ble Judge in Chambers vide Order dated 05.01.2015 (F/A) directed to list applications for substitution and condonation of delay in filing substitution before Hon'ble Court alongwith main matter.

Service is not complete on respondent Nos. 1 to 5.

SLP(C) Nos. 29618-21/2015:-
