**OFFICE REPORT**

The matters above mentioned were listed before the Court of Ld. Registrar on 15.12.2015, when the Court was pleased to inter-alia pass the following Order:-

Four weeks time, as last chance is given to the learned counsel for the petitioners to comply with the terms of the order dated 30.9.2015 of this Court in respect of deceased Respondent No.206 and take fresh steps for the service of notice by usual mode to the respondent No. 34 within a period of four weeks.

**SLP(C) No. 17555/2013**

Four weeks time, as last chance is given to all the respondents to file the counter affidavit.

**SLP(C) No. 7598-7599/2015**

Respondent Nos.1 to 13 and 15 to 22 have already filed the counter affidavit.

Service of notice is complete on the respondent No.23 but no one has entered appearance on his behalf.

Ld. Counsel for the petitioner has filed the spare copy but has failed to file the fresh address of the respondent No.14. Four weeks time, as last chance is granted to the Ld.Counsel for the petitioner to file the fresh address of the Respondent No. 14.

**SLP(C) Nos. 21475-87/2010:-**

It is submitted that as directed above, fresh show cause notice to respondent No. 34 in SLP(C) No. 21475/2010 was issued on 05.01.2016 by regd. A.D. Neither A.D. card nor unserved cover has been received from respondent No. 34 so far.

It is further submitted that counsel for the petitioner has not cured the defects found in application for substitution to bring on record the LRs of deceased Respondent No. 206.

**SLP(C) No. 17555/2013:-**

It is submitted that counsel appearing for all the respondents has not filed counter-affidavit so far.

**SLP(C) Nos. 7598-99/2015:-**

It is submitted that counsel for the petitioner has on 22.12.2015 filed spare copy of SLP but has not furnished the fresh and latest address of unserved respondent No. 14 so far. Hence, fresh show cause notice to said unserved respondent could not be issued.

It is further submitted that counsel appearing for respondent Nos. 1 to 13, 15-102 has already filed counter affidavit. No one has entered appearance on behalf of Respondent No. 23 though served
