OFFICE REPORT

The matters above mentioned were listed before the Court of Ld. Registrar on 30.09.2015, when the Court was pleased to inter-alia pass the following Order:-

"SLP(C) No.21475-21487/2010:-

The office report is that the Ld.counsel for the petitioners has filed an application for substitution to bring on record the Lrs. Of the deceased respondent No.206 in SLP(C) No.21475/2010 which is defective. Ld.counsel shall within a period of four weeks cure the defects whatever have been found in the said application.

Await the return of the service of notice already issued to the respondent No.34 in SLP(C) No.21475/2010.

SLP(C) No.17555/2013 :-

The respondents shall be at liberty to file the counter affidavit within a period of four weeks.

SLP(C) Nos.7598-99/2015:-

Ld.counsel for the petitioners shall within a period of four weeks file the fresh particulars of the respondent No.14 and he shall also take fresh steps for the service of notice to him within the same period. Dasti in addition is permitted to be served.

The served respondents shall be at liberty to file the counter affidavit within a period of four weeks.

SLP(C) Nos.19982 & 19983/2015:-

Fresh steps for the service of notice by usual mode to the unserved sole respondent shall be taken by the Ld.counsel for the petitioners within a period of three weeks. Dasti in addition is permitted to be served.

List the matter again on 15.12.2015. "

SLP(C) Nos. 21475-87/2010:-

It is submitted that Neither A.D. Card nor unserved cover has been received in respect of Respondent No. 34. It is further submitted that counsel for the petitioner has not cured the defects found in application for substitution to bring on record the LRs of deceased Respondent No. 206.

SLP(C) No. 17555/2013:-

It is submitted that counsel appearing for Respondent Nos. 1 to 5 has not filed counter-affidavit so far.

Service is already complete.

SLP(C) Nos. 7598-99/2015:-

It is submitted that counsel appearing for Respondent nos. 1 to 13 and 15 to 22 has filed counter affidavit. No one has entered appearance on behalf of Respondent No. 23 so far. Counsel for the petitioner has filed the spare copy of SLP for issuance of fresh notice to Respondent No. 14 but has not furnished the fresh address alongwith spare copy.

Service is not complete on respondent No. 14.

SLP(C) No. 19982 & 19983/2015:-

It is submitted that A.d. Card duly signed have been received from sole respondent in each matter but no one has entered appearance so far.

Service is complete.
