**SLP(C) Nos. 21475-87/2010:-**

It is submitted that fresh show cause notice to respondent No. 34 in SLP(C) No. 21475/2010 was issued on 14.09.2015 by regd. A.D. Neither A.D. card nor unserved cover has been received so far.

It is further submitted that counsel for the petitioner has already filed application for substitution to bring on record the Lrs. of deceased respondent No. 206 in SLP(C) No. 21475/2010 alongwith application for condonation of delay in filing substitution application but she has not taken out chamber summons in respect of proposed Lrs. despite this Registry's request.
