The matters above mentioned were listed before the Court of Ld. Registrar on 01.12.2016, when the Court was pleased to inter-alia pass the following order:-

Await the return of the service of notice already issued to the sole respondent in SLP (C) No.28464/2015.

SLP (C) Nos.29618, 29619, 29620 & 29621/2012

Await the return of service of notice already issued to the unserved respondents in all matters.

List the matter again on 17.01.2017.

Service position of each matter is given bellow:-

SLP (C) NOS. 28464-28466/2015

It is submitted that neither AD card nor unserved cover containing notice to sole respondent in SLP (C) No. 28464/2015 has been received. Service is already complete on sole respondent in SLP (C) Nos. 28465-28466/2015 but no one has entered appearance so far.

Service is not complete on sole respondent in SLP (C) No. 28464/2015.

SLP (C) NOS. 29618/2015

It is submitted that as per tracking report delviery of notice to Respondent nos. 3, 5, 8 & 9 is not conclusive. AD cards duly signed by Respondent Nos. 1, 2, 4, 6 & 7 received but no one has entered appearance so far.

Service is not complete on Respondent Nos. 3, 5, 8 & 9.

SLP (C) NOS. 29619/2015

It is submitted that AD cards duly signed by respondent nos. 1 to 5 received but no one has entered appearance so far. As per India Post racking report delviery report to Respondent No. 6 is not conclusive.

Service is not complete on Respondent No. 6.

SLP (C) NOS. 29620/2015

It is submitted that as per India Post racking report delivery of notice to Respondent Nos. 1, 2, 7 to 9, 12, 13, 20, 22, 24, 33 & 34 is not conclusive. AD cards have been received from Respondent Nos. 14 & 20 and notice has been delivered to Respondent No. 35. No one has entered appearance so far.

Service is not complete on Respondent Nos. 1, 2, 7-9, 12, 13, 22, 24 & 33 & 34.

SLP (C) NO. 29621/2015

It is submitted that AD cards duly signed by Respondent Nos. 2-6, 8, 10-13 & 16-25 received. As per India Post racking report delivery of notice to Respondent Nos. 1, 7, 9, 14 & 15 is not conclusive.

Service is not complete on Respondent Nos. 1, 7, 9 & 14-15.
