Special Leave Petition (Crl.)Nos. 1360-1361 of 2011
were listed before the Hon'ble Court on 11.02.2011 when the
Court was pleased to pass the following order:

**"Issue notice on the
applications for condonation of delay
as well as on the Special Leave
Petitions."**

Accordingly, Show Cause Notice was issued to sole
respondent in both SLPs on 19.03.2011 through Registered AD
Post. AD card duly signed has been received back from Sole
Respondent in Special Leave Petition (Crl.) No.1360 of 2011,
but no one has entered appearance on behalf of Sole
Respondent.

Unserved cover containing the Show Cause Notice has been
received from Sole Respondent in Special Leave Petition
(Crl.) No.1361 of 2011 with Postal remarks "Addressee out of
station."

The matters above mentioned were listed before the Court
of Registrar from time to time but Counsel for the Petitioner
has not taken any steps for effecting service of sole
Respondent in special leave petition(Crl.)No. 1361 of
2012 and thereafter the matters were listed before the
Hon'ble Judge-in-Chamber on 22nd March, 2012, when the
following order was passed:

**"Further time of four weeks is
granted to the advocate on record for
the petitioner in Special Leave
Petition (Criminal) No. 1361 of 2011**

for compliance of the Office Report on Default dated February 14, 2012, failing which the above stated Special Leave Petition shall stand dismissed without further reference to the Court."

It is submitted that Counsel for the Petitioner did not disclose the correct address of the unserved Sole Respondent nor filed spare copy in Special Leave Petition (Crl.) No.1361 of 2011. Hence, Special Leave Petition (Crl.)No. 1361 of 2011 stood dismissed against sole Respondent.

Service of Show cause Notice is complete in Special Leave Petition(Crl.) No. 1360 of 2011.

The matter above-mentioned is listed before the Hon'ble Court with this Office report.
