SLP is pending after notice (Copy of order dated 29.04.2016 is enclosed herewith).

It is further submitted that SLP (C) CC No. 7974 of 2016 Entitled Harvinder Singh Versus State of Haryana & Ors. arising out of common Judgment was **disposed** of as withdrawn on 13.05.2016 by Hon'ble Court. (Copy of order dated 13.05.2016 is enclosed herewith).
