OFFICE REPORT

It is submitted that the above mentioned Special Leave Petition is filed by Mr. Subhasish Bhowmick, Advocate on 08.02.2016 against the Judgment and Order dated 03.11.2015 of the High Court of Punjab and Haryana at Chandigarh in RFA Nos. 6740, 6743, 6745, 7593, 7594, 7596 of 2011, 908, 1595, 1596 and 2767 of 2012.

It is further submitted that Counsel for the petitioner has filed **two applications** for condonation of delay in filing the SLP and refiling the SLP (i) there is a delay of 2 days in filing the SLP (ii) a delay of 114 days in refiling the SLP. There is a total delay of 116 days in filing and refiling the SLP.

It is further submitted that **notice** in SLP (C) No.17602 of 2016 @ CC 10373 of 2016 Entitled Narain Singh Versus State Of Haryana And Ors. arising out of in which judgment of instant matter is relied upon was directed on 01.07.2016 by Hon'ble Court. SLP is pending after notice (Copy of order dated 01.07.2016 is enclosed herewith).

It is further submitted that **notice** in SLP (C)

No.11063 of 2016 @ CC No.6395 of 2016 Entitled Rajbir And Ors Versus State Of Haryana And Ors arising out of common Order was directed on 11.04.2016 by Hon'ble Court. SLP is pending after notice (Copy of order dated 11.04.2016 is enclosed herewith)(Main matter is SLP (C) No. 11275 of 2016).

It is further submitted that Counsel for the petitioner has not furnished the copies of notification dated 13.08.2004, 26.08.2004 and award dated 25.011.2004. In this regard, counsel has given a **letter** dated 15.07.2016 (Letter is enclosed) stating therein that the same are not necessary and Counsel has requested to ignore the aforesaid defects and list the matter.

The matter is listed before the Hon'ble Court with this office report.
