It is submitted that the above mentioned Special Leave Petition is filed by Mr. Tarun Gupta, Advocate on 08.02.2016 against the Judgment and Order dated 03.11.2015 of the High Court of Punjab and Haryana at Chandigarh in RFA Nos. 1177, 1172-1192, 1194-1205, 1488-1492, 1983, 1984, 1996, 1997, 2277-2280, 2415-2441, 2738-2744, 2752, 2753, 2754, 2755, 2756, 2797, 2802, 2803, 3499, 3931, 3932, 3933, 3934, 3935, 3936, 3937, 3938, 4416, 4436, 4493, 4928, 5070, 5416, 6841 of 2013 (O&M) alongwith application for permission to file Special Leave Petition.

It is further submitted that Counsel for petitioner has also filed an application for **substitution** of

deceased Appellant No. 1 in RFA No. 1197 of 2013 (O & M) namely Taken, Appellant No. 2 in RFA No. 2417 of 2013 (O & M) namely Jagbir Singh, Appellant No. 3 in RFA No. 2417 of 2013 (O & M) namely Dharambir Singh @ Dharamvir, Appellant No. 1 in RFA No. 2425 of 2013 (O & M) and Appellant No. 11 in RFA No. 2437 of 2013 (O & M) namely Krishan Kumar which is within time and Appellant No. 4 in RFA No. 1179 of 2013 (O & M) namely Ram Rattan, Appellant No. 2 in RFA No. 1184 of 2013 (O & M) namely Baljit Singh, Appellant No. 6 in RFA No. 1187 of 2013 (O & M) namely Ashok Kumar, Appellant No. 3 in RFA No. 1192 of 2013 (O & M) namely Fateh Singh, Appellant No. 1 in RFA No. 2421 of 2013 (O & M) namely Bilendr Singh @ Virender, Respondent No. 8 in RFA Nos. 2422 and 2423 of 2013 (O & M) namely Chander Singh, Appellant No. and Appellant No. 18 in RFA No. 2428 and 2437 of 2013 (O & M) namely Singh Ram, Appellant No. 16 in RFA No. 2437 of 2013 (O & M) namely Jai Singh, Appellant No. 3 in RFA No. 3937 of 2013 (O & M) namely Narender Pal which are barred by time by 342, 32, 497, 419, 367, 1464, 15, 640 & 136 days respectively and Counsel has also filed an application for condonation of delay in filing substitution application.

It is further submitted that originally Special Leave Petition was **within time** but there is a delay of 86 days in re-filing the Special Leave Petition.

It is further submitted that the instant matter is **tagged** with SLP (C) D. No. 4899 of 2016 @ CC No. 12380-12429 of 2016 Entitled Anand Etc. Etc. Versus State Of Haryana And Ors. Etc. Etc. as both are arising out of similar issue.

It is further submitted that Counsel for the petitioner has not furnished the copies of

notifications/award/GOs dated 30.06.2005, 05.07. 2006, 27.06.2008, 2.3.206. 10.03.215. In this regard, counsel has given a **letter** that stating therein that the same are not relevant for the adjudication of the case and award dated 07.11.2012 passed by the Addl. District Judge, Sonapat in LAC Case No. 790 of 2009 has been filed as Annexure P-2 with the SLP. Counsel has requested to register and list the matter at his own risk.

The matter is listed before the Hon'ble Court with this office report.
