OFFICE REPORT

It is submitted that Mr.Aditya Singh , Advocate has filed Special Leave Petition on 20.5.2016 against the Judgment and Order dated 3.11.2015 of the High Court of Punjab and Haryana at Chandigarh in RFA nos 3359, 3366, 4685 and 4686 of 2012 alongwith application for permission to file Special Leave Petition.

It is further submitted that Counsel for petitioner has also filed an application for **substitution** of deceased petitioner namely Raghbir and Mohinder Singh in RFA nos. 4686/2012 and 4685/2012 which is barred by time

by 488 and 139 days and Counsel has also filed an application for condonation of delay in filing substitution application.

It is further submitted that Special Leave Petition filed against the Judgment and Order dated 3.11.2015 in RFA No. 3359/2012 is barred by time by 109 days and Counsel for the petitioner has filed an application for condonation of delay in filing the SLP.

It is further submitted that the instant matter is **tagged** with CC No. 11296-11307/2016 Entitled RAGHBIR ETC ETC vs STATE OF HARYANA AND ORS ETC ETC as both are arising out of similar issue.

It is further submitted that Counsel for the petitioner has not furnished the copies of notification dated 14.10.1996, 17.11.2005, 16.11.2005, 7.2.2006, 15.6.2006 and award dated 2.3.2006, 18.3.2008, 10.3.2011 and 31.2.2012 and exhibits. In this regard, **counsel has given a letter** 29.6.2016 (Copy of letter dated 29.6.2016 is enclosed at page no. 126) stating therein that the same are not necessary and counsel has requested to register and list the matter at his own risk.

The matter is listed before the Hon'ble Court with this office report.
