OFFICE REPORT

It is submitted that the above mentioned Special Leave Petition is filed by Mr. Anjani Kumar Mishra, Advocate on 08.02.2016 against the Judgment and Order dated 03.11.2015 of the High Court of Punjab and Haryana at Chandigarh in RFA Nos. 4290, 4875, 5157, 5161, 5162, 5163, 5164, 5166, 5167, 5169, 5731, 5734, 6497, 6499, 7462 & 7464 of 2012 (O&M) along with the application for permission to file SLP and exemption from filing O.T.

It is further submitted that Counsel for petitioner has also filed an application for substitution of LR's of deceased namely Kapil and Harlal which is barred by time by 676 days and 722 days respectively and

Counsel has also filed an application for condonation of delay in filing substitution application.

It is further submitted that Counsel for the petitioner has filed **two applications** for condonation of delay in filing the SLP and refiling the SLP (i) there is a delay of 2 days in RFA Nos. 4290, 4875, 5157 & 6499 of 2012 (O & M) in filing the SLP (ii) a delay of 92 days in refiling the SLP. There is a total delay of 94 & 92 days in filing and refiling the SLP.

It is further submitted that the instant matter is tagged with SLP (C) CC No. 11185-11186 of 2016 Entitled Jagmal @ Jagpal Etc. Versus State Of Haryana And Ors. as both are arising out of common similar issue.

The matter is listed before the Hon'ble Court with this office report.
