OFFICE REPORT

It is submitted that the above mentioned Special Leave Petition is filed by Mr. Satish Kumar, Advocate on 08.02.2016 against the Judgment and Order dated 03.11.2015 of the High Court of Punjab and Haryana at Chandigarh in RFA Nos. 3378, 3380-3386, 3388-3390, 3392, 3393, 4317, 4320, 4326, 4329, 4330, 4340, 4850, 4852, 5504, 6493, 6495, 6496 of 2012, 513, 514, 527, 532, 533, 534, 535, 536, 1646, 5415 of 2013 and 4682 of 2014 alongwith application for permission to file Special Leave Petition and exemption from filing official translation.

It is further submitted that Counsel for petitioner has also filed an application for **substitution** of deceased Petitioner No. 7 in RFA no. 3378 of 2012 namely Shani Kumar, Petitioner No. 21 in RFA No. 3386 of 2012 namely Rohtash, Petitioner No. 1 in RFA Nos. 533, 534 of 2013, Petitioner No. 5 in RFA Nos. 535 of 2013 & Petitioner No. 9 in RFA No.4682 of 2014 namely Shyam Singh, Petitioner No. 2 in RFA Nos. 4850 of 2012, Petitioner No. 4 in RFA No. 513 of 513 of 2013 & Petitioner No. 1 in RFA No. 514 of 2013 namely Raj Ram, Petitioner No. 5 in RFA No. 513 of 2013 namely Pritam Singh which are barred by time by 1023, 1001, 92, 924 and 1240 days respectively and Counsel has also filed an application for condonation of delay in filing substitution application.

It is further submitted that Counsel for the petitioner has filed **two applications** for condonation of delay in filing the SLP and refiling the SLP (i) there is a delay of 2, 4 and 6 days in filing the SLP in RFA Nos. 4317, 4320, 4326, 4329, 4330 of 2012 & 6496 of 2012 and 532 of 2013 respectively (ii) a delay of 63 days in refiling the SLP. There is a total delay of 65, 67, 72 and 63 days in filing and refiling the SLP.

It is further submitted that the instant matter is **tagged** with SLP (C) CC Nos. 9220-9223 of 2016 Entitled Raj Kumar And Anr Etc Versus State Of Haryana And Ors Etc as both are arising out of common Order.
