OFFICE REPORT

It is submitted that Mr.Ranbir Singh Yadav, Advocate has filed Special Leave Petition on 19.2.2016 against the Judgment and Order dated 3.11.2015 of the High Court of Punjab and Haryana at Chandigarh in RFA Nos. 4574, 4575 and 4582 of 2012 and 2915 of 2014 alongwith application for permission to file Special Leave Petition.

It is further submitted that Counsel for petitioner has also filed an application for substitution of deceased Appellant No. 1 namely Jiya Ram in RFA no. 4575/2012 which is barred by time by 404 days and Counsel has also filed an application for condonation of delay in filing substitution application.

It is further submitted that SLP filed against the Order dated 19.2.2016 in RFA Nos. 4575, 4582 of 2012 and 2915 of 2015 is within time, whereas there is a delay of 4 days in filing the SLP against the Order dated 19.2.2016 in RFA Nos. 4574/2012. Further there is a delay of 48 days in refiling in all the SLPs. Thus there is a total delay of 4 days and 52 days in filing and refiling the SLPs.

It is further submitted that notice in SLP (C) No.11275/2016 @CC No. 5690/2016 Entitled RAJBIR AND ORS vs STATE OF HARYANA AND ORS arising out of similar issue was directed on 11.4.2016 by the Hon'ble Court. SLP is pending after notice (Copy of order dated 11.4.2016 is enclosed herewith).

It is further submitted that SLP (C) No.6600-6610/2016 Entitled MADAN LAL ETC. ETC. vs STATE OF HARYANA & ORS. ETC. ETC. arising out of common order was disposed of as withdrawn on 14.3.2016 by the Hon'ble Court. (Copy of order dated 14.3.2016 is enclosed herewith).

The matter is listed before the Hon'ble Court with this office report.
