It is submitted that Mr. U.S. Prasad, Advocate has filed Special Leave Petition on 18.03.2016 against the Judgment and Order dated 03.11.2015 of the High Court of Punjab and Haryana at Chandigarh in RFA Nos. 786, 4859, 5427, 5431, 5608, 5612-5615, 6508, 6510, 6511, 6512, 6514 of 2012, 1118, 1643 of 2013, 388,3852 of 2014, Cross Objection No. 70-CI of 2014 in RFA no. 3248/2012, Cross

Objection No. 97-CI of 2014 in RFA no. 3923/2012, Cross Objection No. 49-CI of 2015 in RFA no. 3523/2012 (O&M) and Cross Objection No. 52-CI of 2015 in RFA no. 3519/2012 (O&M) alongwith application for permission to file Special Leave Petition.

It is further submitted that Counsel for petitioner has also filed an application for substitution of deceased petitioner no. 1 namely Suraj Mal in RFA No. 5427/2012 (Which is within time), Petitioner no. 1 namely Munshi in RFA No. 6508/2012, sole petitioner namely Phool Singh in RFA No. 5614/2012, Petitioner no. 2 namely Phool Singh in RFA No.1118/2013 which are barred by time by 509, 335 & 335 days respectively and Counsel has also filed an application for condonation of delay in filing substitution application alongwith application for setting aside abatement in RFA Nos. 5427, 5614, 6508/2012 & RFA No. 1118/2013.

It is further submitted that Special Leave Petition filed against the Judgment and Order dated 03.11.2015 is barred by time by 38 days and Counsel for the petitioner has filed an application for condonation of delay in filing the SLP.

It is further submitted that the instant matter is tagged with SLP (C) CC Nos. 8634-8635 of 2016 Entitled Rajender Singh Etc. Versus State Of Haryana & Ors. Etc. as both are arising out of similar issue.

The matters are, therefore, listed before the Hon'ble Court with this office report.
