OFFICE REPORT

It is submitted that the above mentioned Special Leave Petition is filed by Mr. Subhasish Bhowmick, Advocate on 12.02.2016 against the Judgment and Order dated 03.11.2015 of the High Court of Punjab and Haryana at Chandigarh in RFA No. 4631 of 2012 alongwith application for permission to file Special Leave Petition.

It is further submitted that Counsel for petitioner has also filed an application for **substitution** of deceased appellant No. 1 namely Raj Pal which is barred by time by 277 days and Counsel has also filed an application for condonation of delay in filing substitution application.

It is further submitted that originally Special Leave Petition was **within time** but there is a delay of 32 days in re-filing the Special Leave Petition.

It is further submitted that **notice** in SLP (C) No.11275 of 2016 @ CC No. 5690 of 2016 Entitled State Of Haryana And Ors. Versus State Of Haryana And Ors. arising out of similar issue was directed on 11.04.2016 by Hon'ble Court. SLP is pending after notice (Copy of order dated 11.04.2016 is enclosed herewith).

It is further submitted that SLP (C) Nos. 6600-6610 of 2016 Entitled Madan Lal Etc. Etc. Versus State of Haryana & Ors. Etc. Etc. arising out of common Order was disposed of withdrawn on 14.03.2016 by Hon'ble Court. (Copy of order dated 14.03.2016 is enclosed herewith).

It is further submitted that Counsel for the petitioner has not furnished the copies of order dated 17.11.2005, 02.03.2006, 10.03.2001, 16.11.2005, 18.03.2008 and some exhibits. In this regard, counsel has given a **letter** dated 22.04.2016 (Letter is enclosed) stating therein that the same are not necessary and Counsel has requested to ignore the aforesaid defects and list the matter at his own risk.

The matter is listed before the Hon'ble Court with this office report.
