OFFICE REPORT

It is submitted that the above mentioned Special Leave Petition is filed by Mr. Umang Shankar, Advocate on 19.07.2016 against the Judgment and Order dated 03.11.2015 of the High Court of Punjab and Haryana at Chandigarh in RFA No. 1488 of 2012 (O & M) alongwith applications for permission to file Special Leave Petition and exemption from filing official translation.

It is further submitted that Counsel for petitioner has also filed an application for **substitution** of deceased petitioner No. 4 in RFA No. 1488 of 2012 namely Rajender which is barred by time by 423 days and Counsel

has also filed an application for condonation of delay in filing substitution application.

It is further submitted that Counsel for the petitioner has filed **two applications** for condonation of delay in filing the SLP and refiling the SLP (i) there is a delay of 164 days in filing the SLP (ii) a delay of 24 days in refiling the SLP. There is a total delay of 188 days in filing and refiling the SLP.

It is further submitted that the instant matter is **tagged** with SLP (C) D. No. 29505 of 2016 @ CC Nos.17312-17313 of 2016 Entitled Sushil Kumar Aggarwal & Etc. Etc. Versus State Of Haryana & Ors. as both are arising out of common Order.

It is further submitted that Counsel for the petitioner has not furnished the copies of notification dated 22.06.2006, 20.06.2007, 28.03.2006, 19.06.2006 & 17.11.2005, award dated 22.05.2007, 28.11.2005 and exhibits. In this regard, counsel has given a **letter** dated 10.09.2016 (Letter is enclosed in paper books at page no.179) stating therein that the same are not required and Counsel has requested to ignore the aforesaid defects and list the matter at his own risk.

The matter is listed before the Hon'ble Court with this office report.
