It is submitted that Mr.Ranbir Singh Yadav, Advocate has filed Special Leave Petition on 28.6.2016 against the Judgment and Order dated 3.11.2015 of the High Court of Punjab and Haryana at Chandigarh in RFA Nos 4866 and 4868/2012(O&M) alongwith application for permission to file Special Leave Petition.

It is further submitted that Counsel for petitioner has also filed an application for **substitution** of deceased petitioner namely Smt. Chhoto and Raj Kumar in RFA Nos. 4866 and 4868 of 2014 which is barred by time by 1257 and 709 days and Counsel has also filed an application for condonation of delay in filing substitution application.

It is further submitted that Special Leave Petition filed against the Judgment and Order dated in RFA No. 4866 and 4868/2014 is barred by time by 147 days and Counsel for the petitioner has filed an application for condonation of delay in filing the SLP.

It is further submitted that **notice** in SLP (C) No. 12286-12300/2016 @ CC No.7168-7182/2016 Entitled KUSHAL ETC vs STATE OF HARYANA AND ORS ETC arising out of common order was directed on 21.4.2016 by Hon'ble Court. SLP is pending after notice (Copy of order dated 21.4.2016 is enclosed herewith).

It is further submitted that **notice** in SLP (C) No. 13502-13513/2016 @ CC No. Entitled DHARAMVIR ETC. vs STATE OF HARYANA AND ORS. ETC. arising out of common order was directed on 6.5.2016 by Hon'ble Court. SLP is pending after notice (Copy of order dated 6.5.2016 is enclosed herewith).

It is further submitted that Counsel for the petitioner has not furnished the copies of notification dated 17.1.2005 and 17.2.2006, Award dated 2.3.2006 and 18.3.2008 and exhibits. In this regard, **counsel has given a letter dated 25.7.2016** (Copy of letter is enclosed) stating therein that the same are not necessary and counsel has requested to register and list the matter at his own risk.

The matter is listed before the Hon'ble Court with this office report.
