Learned Counsel for the State submits that in some matters,

Issue notice in all fresh matters.

Our attention has been invited to the earlier order passed by
this Court on 22.11.2019. We pass similar directions and direct as
under:

a) Delay condoned.

Subject to the petitioner-State depositing a sum of Rs.50,000/- (Rupees fifty thousand only), to the account of every petition in the Registry of this Court within four weeks from today, let notices be issued to the respondents, returnable on 24.02.2020.

Dasti service, in addition, is permitted.

- b) If the amount is not deposited within the stipulated time, the special leave petitions shall stand dismissed without further reference to the Court.
- c) Upon deposit, the amount shall be invested in a fixed deposit receipt with a nationalized bank initially for a period of 90 days with auto renewal facility.

In all these matters, let the steps be undertaken within three days from today to effectuate service upon the unserved respondents.
