O R D E R

Ld. counsel for the petitioner submits that the main SLP which was converted into Civil Appeal No.6825/2019 has been disposed of by an order dated 2.9.2019. According to him, present SLPs are also arising out of the judgment that has been dealt with in the aforesaid appeal.
