All matters

Ld. Counsel for the petitioner to take fresh steps to effect service on the unserved respondents as mentioned in the office report within two weeks time.

Ld. Counsel for the petitioner to take fresh steps alongwith complete address to effect service on respondent no.5 in SLP(C) No. 4488/2019, respondent no.4 in SLP(C) No. 7962/2019, sole respondent in SLP(C) No. 12028/2019 and sole respondent in SLP(C) No. 14450, 14455, 19770 of 2019 within two weeks time.

Ld. Counsels appearing for the duly represented respondents appearing for the first time are granted four weeks time for filing counter affidavit.
