OFFICE REPORT

The matter above mentioned was listed before the Hon'ble Court on 10.04.2015 & 14.5.2015, when the Court was pleased to pass the following order:-

" Order dated 10.4.2015

Delay condoned.

Issue notice, returnable within four weeks, to the respondents, limited to the extent of asking the petitioner to give an affidavit contrary to the provisions of Rule 10 of the Punjab Town Improvement (Utilization of Land & Allotment of Plots) Rules, 1983.

"Order dated 14.5.2015

The filing of the affidavit by the petitioner, as demanded by the respondent(allotment authority), is stayed for the present."

It is submitted that show cause notice was issued to all the five respondents by registered A.D. Post on 23.4.2015.

It is further submitted that Mr. Devendra Singh, counsel has on 28.7.2015 filed Vakalatnama & Memo of Appearance on behalf of respondent no. 2. He has also filed Counter Affidavit on his behalf on 5.3.2016 after stipulated time. However, copy of the Counter Affidavit has already been included in SLP paper books.

It is further submitted that Dr. (Mrs.) Vipin Gupta, Advocate has on 12.7.2016 filed Vakalatnama & Memo of Appearance on behalf of Respondent No.3 but no Counter

Affidavit has been filed so far.

It is further submitted that despite service no one has entered appearance on behalf of respondent nos. 1, 4 and 5 so far.

The matter above mentioned was lastly listed before the Ld. Registrar's Court on 12.2.2016, when the following Order was passed:-

" Respondent no. 2 has failed to file the counter affidavit within the period stipulated under the Rules. Service of notice is complete on the respondent nos. 1 and 3 to 5, but no one has entered appearance on their behalf. Therefore, the matter shall be processed for listing before the Hon'ble Court under the Rules."

Service of show cause notice is complete.

The matter is listed before the Hon'ble Court with this office report.
