"C.A. No. 2762/2012

The Ld. Counsel for the appellant submits that he will file the ad-valorem court fee within four weeks. Time is granted, as prayed for.

C.A. No. 1832/2014

The Ld. Counsel for the appellant to furnish the latest and correct address of the sole respondent within four weeks.

C.A. No. 10146 and 10500/2014

The Ld. Counsel for the appellant submits that he will file the deficit ad-valorem court fee within four weeks. Time is granted, as prayed for.

C.A. Nos.150 and 721/2015

The Ld. Counsel for the appellant submits that he will file the ad-valorem court fee within four weeks. Time is granted, as prayed for.

C.A. No. 1141/2015

Await certificate of service of the sole respondent from the High Court.

C.A NO. 2762 OF 2012

It is submitted that Counsel for the Appellant has on 12th September, 2016 filed

Ad-Valorem Court fee of Rs. 1750/- which is **barred by time by 35 days.**

It is further submitted that there is sole respondent in the matter above-mentioned and is represented through counsel.

It is also submitted that counsel for the appellant has filed statement of case but counsel for the respondent has not filed statement of case so far, time expired.

Service is complete.

The matter is ready for pre-final hearing.

C.A. NO. 1832 OF 2014

It is submitted that Counsel for the Appellant **has not furnished the latest and correct address of the sole respondent** till date and Counsel for the Appellant has on 12th September, 2016 filed the Ad Valorem Court fee of Rs. 1750/- in the matter.

C.A. NO. 10146 AND 10500 OF 2014

It is submitted that that there is sole respondent in the matters above-mentioned and is represented through counsel.

Service is complete in all the matters.

It is further submitted that Counsel for the Appellant has paid Ad-Valorem Court fee of Rs. 2,93,000/- and Rs. 77,000/- in C.A. Nos. 10146 and 10500 of 2014 respectively but total Court fee required in C.A. Nos. 10146 and 10500 of 2014 is Rs. 3,21,000/- and Rs. 1,05,000/- respectively. She has been informed for the same but she has not done the needful so far.

C.A. NO. 10147 OF 2014

C.A. NO. 3157 OF 2012

"C.A. No. 3157/2012

Name of respondent, mentioned in the fresh and correct address of respondent filed by learned Counsel for appellant, does not tall with the name of respondent in petition of appeal. Hence, two weeks time is granted for rectifying the defects and for furnishing correct address of sole respondent."

[[It is submitted that counsel for the appellant has neither cured the defects of correct address of the sole respondent nor filed the application for amendment of cause title in the matter above mentioned till date.

It is further submitted that Counsel for both the parties **have not filed Statement of Case** in all the matters till date.

C.A. NOS. 150, 650, 721 AND 4316 OF 2015

It is submitted that there is sole respondent and represented through Counsel.

Service is complete.

It is further submitted that Counsel for both the parties **have not filed Statement of Case** in all the matters till date.

It is also submitted that Counsel for the Appellant **has not filed Affidavit of Valuation as per new amended rule SCR 2013** in all the matters so far.

C.A. NOS. 1141 OF 2015

It is submitted that there is sole respondent and represented through Counsel.

Service is complete.

It is further submitted that Counsel for both the parties **have not filed**

Statement of Case in the matter till date.

The matter is ready for pre-final hearing.

C.A NO. 1332 OF 2013

It is submitted that there is sole respondent and represented through Counsel.

Service is complete.

It is submitted that Counsel for the Appellant has on 19th May, 2016 filed affidavit of valuation with Court fee of Rs. 8,73,000/- stating therein that assessment year 2005-06 involving tax effect of Rs. 8,77,21,147/-. The Advocate was asked vide this Registry's letter dated 2nd July, 2016 to pay the deficit Court fee of Rs. 23,000/- but she has not done the needful so far.
