It is submitted that there are 7 respondents in the matter. Respondent Nos. 1-2 are represented through counsel and counter affidavit has been filed. Counter affidavit has been included in the paper books. Neither AD Cards nor unserved covers containing notice have been received back from respondent nos. 3-6 so far. Respondent No. 7 is dead.

It is further submitted that applications for transposing and adding respondent Nos. 3-6 as petitioner Nos. 7-10 and substitution and condonation of delay and setting aside abatement of deceased respondent No. 7 filed by Mr. Gopal Singh, Counsel for the petitioner were listed before the Hon'ble Court (In Chamber) on 23.9.2014, when the Court was pleased to pass the following order :-

“ None appeared for the petitioners.

IA No. 3, application on behalf of Respondent Nos. 3 to 6 for being transposed as petitioner is allowed.

IA No. 4 application for substitution and IA No. 5 applications for condonation of delay in filing the application for substitution are also allowed.

List the matter before an appropriate Bench.”

It is further submitted that counsel for the petitioner has not filed requisite Court Fees of Rs. 750/- so far. Therefore, Respondent Nos. 3-6 could not be added as

petitioner Nos. 7-10. Further, it is stated that Lrs. of deceased respondent No. 7 could not be brought on record since the proposed Lrs. of deceased respondent No. 7 and Respondent Nos. 3 to 6 are the same parties. Hence service of show cause notice in respect of respondent Nos. 3-7 is still incomplete and Cause Title could not be amended.

The matters are listed before the Hon'ble Court with this office report.
