The matter above-mentioned was listed before the Hon'ble Court on 13.04.2015, when the Court was pleased to pass the following order:

**"Issue notice to be tagged with Civil Appeal@ SLP(C) No.7526 of 2010."**

It is submitted that pursuant to aforesaid order, notice has been issued to all the 24 respondents Mr. M.P. Shorawala, Advocate has filed vakalat/appearance on behalf of respondent nos. 1, 3-6, 8-14, 15, 17 and 19-21 but no counter affidavit has been filed so far.

It is further submitted that Mr. Rajiv Nanda, Advocate has been filed vakalat/appearance and counter affidavit on behalf of respondent nos. 22-24 (copy included in paper books).

The matter above-mentioned was listed before Registrar Court time to time and was lastly listed on 07.01.2016 when the Court passed the following order:

**"Respondent Nos. 2, 16 and 18 are reported to be dead. The learned counsel for the petitioners shall within a period of four weeks file an application for substitution to bring on record their Lrs.**

**The learned counsel for the petitioners shall within a period of four weeks file the fresh particulars of the respondent No. 7 and he shall also take appropriate steps for the service of notice to him within the same period.**

**Respondent Nos. 22 to 24 have already filed the counter affidavit.**

**Four weeks time, as last chance is given to the respondent Nos. 1, 3 to 6, 8 to 15, 17, 19 to 21 to file the counter affidavit.**

**List again on 29.2.2016."**

It is lastly submitted that counsel for the petitioner has filed a letter dated 01.03.2016 requesting therein to the counsel of respondent for providing necessary documents in respect of deceased respondent nos. 2,16 and 18 (copy of letter dated 01.03.2016 is enclosed herewith).

Service of notice is not complete on respondent Nos. 2, 7, 16 and 18.

The matter is listed before the Hon'ble Court with this office report.
