The matter above mentioned was listed before the Hon'ble Court on 2.7.2013 when the Court was pleased to pass the following order:

In the meanwhile, the petitioner, however, will file copy of the reply of Respondent No. 2 on the basis of which the High Court has rejected the prayer in the Arbitration Petition."

It is submitted that pursuant to aforesaid order show cause notice to both the respondents was issued on 17.7.2013 by Regd. AD. Mr. S.K. Dhingra, Advocate has filed vakalatnama/appearance as well as counter affidavit on behalf of respondent No.1. Counter affidavit has been included in the SLP paper books. Mr. Prem Prakash, Advocate has filed vakalatnama/appearance on behalf of Respondent No.2 but he has not filed counter affidavit. Counsel for the petitioner has on 6.7.2013 filed requisite copy of short reply of Respondent No.2 and the same has been included in SLP paper books.

For non-filing of counter affidavit by counsel appearing for respondent No.2, the matter was listed before the Ld.Registrar Court on 19.08.2013 and lastly listed on 25.9.2013 when the Court was pleased to pass the following order:

"Respondent No.1 has filed Vakalatnama and counter affidavit. Respondent No.2 submit that counter is ready and will be filed within a week. File the Counter affidavit accordingly.

List the matter before the Hon'ble Court as per rules, after expiry of the week."

It is further submitted that counsel appearing for respondent No.2 has on 8.10.2013 filed counter affidavit and the same has been included in SLP paper books.
