OFFICE REPORT

It is submitted that Dr. Kailash Chand, Advocate has filed Special Leave Petition on 06.01.2016 against the Judgment and Order dated 06.10.2015 of the High Court of Punjab and Haryana at Chandigarh in RFA Nos. 4330,5359 of 2010, 2872/2012, 4574/2013, 4199, 6505, 4200, 6498, 6504, 3376, 3374, 6499, 2249, 3215, 3373, 6502, 3064, 7215, 2247, 3230, 2868, 3221 of 2011, 4171, 4359/2010, 2869, 3061 of 2011, 1971, 7112, 1972, 7116, 1969, 7110 of 2013, 3073, 6146, 3078, 3708/2011, 4358/2010, 1714, 3199/2011, 2616, 1023,4564/2013, 4331/2010, 1197/2011, 4363, 5360, 4352/2010, 1196, 3184, 4113, 2864, 3071, 2867, 3076, 3211, 3364, 3103, 3212, 3102, 3203, 3104, 3206, 3197, 5343/2011, 3175, 4181/2010, 4446, 5902/2013, 3375, 6497, 3193, 4136, 4842, 3063, 6482, 6525, 624 and 626 of 2011

alongwith application for permission to file Special Leave Petition.

It is further submitted that Counsel for petitioner has also filed an application for substitution to bring on record the LRs of deceased petitioner no. 4 namely Ram Kishan in RFA No. 4446, 624, 626 of 2011, Petitioner no. 1 namely Ram Phal in RFA No. 4136/2011, petitioner no. 5 namely Chand Bai in RFA No. 3063/2011, petitioner no. 1 namely Ram Kumar in RFA no. 6482/2011, petitioner no. 1 namely Hoti Ram in RFA No. 6525 of 2011 which are barred by time by 928,1086,302,1403 and 3929 days respectively and Counsel has also filed an application for condonation of delay in filing substitution application.

It is further submitted that notice in SLP (C) No. 3067-3082 of 2016 @ CC Nos. 1133-1148 of 2016 entitled Bodan & Ors. Etc. Etc. versus State of Haryana Through HSIDC IMT & Ors. Etc. arising out of common order was directed by the Hon'ble Court on 27.01.2016. SLP is pending after notice (Copy of order dated 27.01.2016 is enclosed herewith). (Main SLP (C) No. 33902-33909/2014)

It is further submitted that SLP (C) No. nos. 7086-7090 of 2016 @ CC No. 3942 of 2016 entitled Asylum Estate LLP Etc. Etc. versus State of Haryana & Ors. Was directed to be tagged with SLP (C) No. 5444-5448/2016 (CC nos. 2585-2586/2016) by the Hon'ble Court on 08.03.2016 (Copy of order dated 08.03.2016 is enclosed herewith).

It is further submitted that Counsel for the petitioner has not furnished copy of order dated 07.03.2002, 25.11.2002, 27.09.2005, 26.02.2002, 18.11.2002, 28.12.2007, 24.12.2003, 30.11.2010, 20.05.2004, 22.07.2003, 27.07.2006, 24.01.2007, relied upon judgment dated RFA Nos. 2374, 5899 of 2013 and exhibits mentioned in the impugned judgment as per his

undertaking letter dated 02.02.2016. In this regard, Counsel has given a letter dated 14.03.2016 (at page no. 489 of the Paper Books) stating therein that the same are not available and are not relevant for adjudication of the matter and has requested to list the matter before the Hon'ble Court at his risk.

The matters are listed before the Hon'ble Court with this office report.
