It is submitted that the above mentioned Special Leave Petition is filed by Ms. Usha Nandini V., Advocate on 02.01.2016 against the Judgment and Order dated 06.10.2015 of the High Court of Punjab and Haryana at Chandigarh in RFA Nos. 4837 of 2010, 4364 of 2010, 4158 of 2010, 3503 of 2010, 4177 of 2010, 3145 of 2010, 4674 of 2010, 4334 of 2010, 4235 of 2010, 4341 of 2010, 4236 of 2010, 4328 of 2010, 5482 of 2010, 4342 of 2010, 4740 of 2010, 4357 of 2010 along with the applications for permission to file additional documents and exemption from filing official translation.

It is further submitted that Counsel for petitioner has also filed an application for substitution of

deceased Appellant No. 1 in RFA No. 4837 of 2010 and Respondent No. 1 in RFA No. 4364 of 2010 namely Bodan Singh and Appellant No. 2 in RFA No. 4837 of 2010 and Respondent No. 2 in RFA No. 4364 of 2010 namely Charan Singh which is barred by time by 1681 days and 179 days and Counsel has also filed an application for condonation of delay in filing substitution application.

It is further submitted that notice in SLP (C) No. 10832 of 2015 Entitled Shyam Singh Versus State Of Haryana And Ors. arising out of common followed Judgment was directed on 13.04.2015 by Hon'ble Court. It is further submitted that in SLP (C) No. 33240 of 2011 Entitled Ram Phal Singh Versus State Of Haryana & Ors. arising out of common followed Judgment, while granting leave, appeal (Civil Appeal No. 4985 of 2013) was allowed on 02.07.2013 by Hon'ble Court. (Copy of the Order dated 02.07.2013 is enclosed herewith). Main matter C.A. Nos. 4843-4940/2013.
