OFFICE REPORT

The matters above mentioned were listed before the Ld. Registrar's Court on 13.07.2015, when the following Order was passed:-

" SLP(C) Nos.33902-33909/2014

The office report suggests that the respondent No.1 in SLP(C) No.33906/14 and respondent No.7 in SLP(C) No.33907/14 have expired.

Accordingly, Ld.counsel for the petitioner in both the SLPs to file applications for substitution to bring on record the Lrs. of the said respondents within four weeks as last opportunity.

SLP(C) No.10832/2015

Await service in respect of both the respondents.

Post both the matters again on 23.09.2015."

SLP(C) Nos.33902-33909/2014

It is submitted that Mr. A.D.N. Rao, Advocate for the petitioner has on 22.01.2015 filed affidavit of dasti service of show cause notice alongwith proof which reveals that service of show cause notice has been effected on all the respondents.

It is further submitted that Dr. Kailash Chand, Advocate has on 20.02.2015 filed Vakalatnama & Memo of Appearance on behalf of Respondent No. 1 in SLP (C) Nos.

33904 & 33908/2014 and on behalf of proposed LRs of deceased Respondent No. 1 in SLP (C) No. 33906/2014 but no application for substitution of LRs of Respondent No. 1 in SLP (C) No. 33906/2014 has been filed by any of the Advocates so far.

It is further submitted that Respondent No. 7 in SLP (C) No. 33907/2014 is reported to be dead. But application for substitution of her LR has not been filed so far.

It is further submitted that Mr. S.K. Sabharwal, Advocate for Respondent No. 10 in SLP (C) No. 33907/2014 has expired and notice for alternative arrangement has been issued on 25.07.2015 but no one has entered appearance on his behalf so far. Respondent No. 9, 11 to 13 in SLP (C) No. 33907/2014 are represented through Ms. Amita Gupta, Advocate.

It is further submitted that none of the represented respondents have filed Counter Affidavits so far.

Service of show cause notice is not complete in respect of Respondent No. 1 (since dead) in SLP (C) No. 33906/2014 and Respondent No. 7 (since dead) and 10 in SLP (C) No. 33907/2014.

SLP (C) No. 10832/2015

It is submitted that neither A.D. card nor unserved cover containing notice has been received back in respect of both the respondents (i.e. State).

Service of show cause notice is not complete.

The matters are listed before the Ld. Registrar with this office report.
