SLP (C) Nos. 33902-33909/2014

The matter above mentioned was listed before the Ld. Registrar's Court on 23.03.2015, when the following Order was passed:-

" SLP(C) No.33904/2014

The respondent No.1 shall be at liberty to file the counter affidavit within a period of four weeks. Service of notice is complete on the other respondents, but no one has entered appearance on their behalf.

SLP(C) No.33908/2014

The office report is that the respondent No.1 has expired. Ld.counsel for the petitioner shall within a period of four weeks file an application for substitution to bring on record the lrs.of the said respondent. List again on 13.07.2015.

In all other matters, service of notice is complete on the respondents, but no one has entered appearance on their behalf. Viewed in that context, the same shall be processed for listing before the Hon'ble Court as and when the connected ones get ready."

It is submitted that Mr. A.D.N. Rao, Advocate for the petitioner has on 22.01.2015 filed service of dasti show cause notice alongwith proof which reveals that service of show cause notice has been effected on all the respondents.

It is further submitted that Dr. Kailash Chand, Advocate has on 20.02.2015 filed Vakalatnama & Memo of Appearance on behalf of Respondent No. 1 in SLP (C) Nos. 33904 & 33908/2014 and on behalf of LRs of deceased Respondent No. 1 in SLP (C) No. 33906/2014 but no application for substitution of LRs of Respondent No. 1 in SLP (C) No. 33906/2014 has been filed by any of the Advocates.

It is further submitted that Respondent No. 7 in SLP (C) No. 33907/2014 is reported to be dead. But application for substitution of her LR has not been filed so far.

It is further submitted that Respondent No. 10 in SLP (C) No. 33907/2014 is represented through Mr. S.K. Sabharwal, Advocate while Respondent No. 9, 11 to 13 in SLP (C) No. 33907/2014 are represented through Ms. Amita Gupta, Advocate. But none of the represented respondents have filed Counter Affidavits so far.

Service of show cause notice is complete on all the respondents except Respondent No. 1 in SLP (C) No. 33906/2014 and Respondent No. 7 in SLP (C) No. 33907/2014 who have been reported to be dead.

SLP (C) No. 10832/2015

The matter above mentioned was listed before the Hon'ble Court on 13.04.2015, when the Court was pleased to pass the following order:-

" Exemption from filing certified copy of the impugned judgment is allowed.

I.A. for deletion of proforma respondents is allowed.

Issue notice.

Tag with SLP(C)Nos. 33902-33909 of 2014 (@ CC Nos. 18542-18549 of 2014)."

Accordingly, show cause notice to both the respondents was issued on 30.04.2015.

It is submitted that neither A.D. card nor unserved cover containing notice has been received back so far.

Service is not complete.

The matters are listed before the Ld. Registrar with this office report.
