It is further submitted that in SLP (C) No. **17962-18059 of 2011** Entitled Haryana State Indusl.Devt.Corp.Ltd. Vs. Udal & Ors.Etc.Etc. arising out of similar issue, **while granting leave**, appeal (Civil Appeal No. 4843-4940 of 2013) was allowed on 02.07.2013 by Hon'ble Court. (Copy of order dated 02.07.2013 is annexed as Annexure P-3 at page nos. 45-75 in the paper books).

It is further submitted that SLP (C) No.29496 of 2013 Entitled Rameshwar Dass & Ors. Versus Land Acquisition Collector Cum Sdo& Ors. arising out of common followed Judgment was **disposed of** on 13.09.2013 by Hon'ble Court. (Copy of order dated 13.09.2013 is enclosed herewith).
