It is submitted that Mr.Gagan Gupta, Advocate has filed Special Leave Petition on 13.6.2016 against the Judgment and Order dated 6.10.2015 of the High Court of Punjab and Haryana at Chandigarh in RFA Nos. 4319, 1088, 4013 of 2013, 2678 of 2012 and 4588 of 2011 alongwith application for permission to file Special Leave Petition, Application for discharge from guardianship and exemption from filing official translation of Annexures A to C.

It is further submitted that Counsel for petitioner has also filed an application for **substitution** of deceased appellant namely Chander Kala in RFA NO. 2678 of 2012 and appellant namely Ghamandi Lal which is barred by time by 329 and 1952 days and Counsel has also filed an application for condonation of delay in filing substitution application.

It is further submitted that Counsel for the petitioner has filed **two applications** for condonation of delay in filing the SLP and refiling the SLP (i) there is a delay of 161 days in filing the SLP (ii) a delay of 71 days in refiling the SLP. There is a total delay of 232 days in filing and refiling the SLP.

It is further submitted that SLP (C) No.14595-609/2016@ SLP (C)CC No.8589-8603/2016 Entitled Harish Kumar Etc. Versus State of Haryana and Ors. Etc. arising out of common order was listed before the Hon'ble Court on 9.5.2016 (Copy of order dated 9.5.2016 is enclosed herewith).

It is further submitted that SLP (C) No.3661/2016 Entitled KOHLI HOLDINGS PVT. LTD., ORIENT CRAFT LIMITED vs STATE OF HARYANA AND ORS. arising out of common order was listed before the Hon'ble Court on 27.9.2016 and directed to list the matter on 22<sup>nd</sup> November, 2016.
