It is submitted that the above mentioned Special
Leave Petition is filed by Mr. Gagan Gupta, Advocate on
30.05.2016 against the Judgment and Order dated
06.10.2015 of the High Court of Punjab and Haryana at
Chandigarh in RFA Nos. 958, 4012, 2138 and 1359 of 2013
along with the applications for deletion of proforma
respondents and exemption from filing official
translation Annexure A.

It is further submitted that Counsel for petitioner has also filed an application for **substitution** of deceased Appellant No. 1 in RFA No. 4012 of 2013 namely Chander Kala which is barred by time by 315 days and Counsel has also filed an application for condonation of delay in filing substitution application.

It is further submitted that petitioner Nos. 4 to 6 in SLP arising out of RFA No. 2138 of 2013 have become major and discharge petitioner no. 2 as their guardian.

It is further submitted that Counsel for the petitioner has filed **two applications** for condonation of delay in filing the SLP and refiling the SLP (i) there is a delay of 147 days in filing the SLP. (ii) a delay of 63 days in refiling the SLP. There is a total delay of 210 days in filing and refiling the SLP.

It is further submitted that SLP (C) Nos.3067-82 of 2016 @ CC Nos.1133-1148 of 2016 Entitled Bodan And Ors. Etc. Etc. Versus State Of Haryana Through HSIDC Ltd. And Ors. Etc. arising out of common Order relied upon was listed before the Hon'ble Court on 27.01.2016 when the Hon'ble Court was directed to issue of notice. The said SLP is pending after notice.(Copy of order dated 27.01.2016 is enclosed herewith)(Main matter is SLP (C) Nos.33902-909 of 2014).

The matter is listed before the Hon'ble Court with this office report.
