OFFICE REPORT

It is submitted that Dr. Kailash Chand, Advocate has filed Special Leave Petition on 07.06.2016 against the Judgment and Order dated 06.10.2015 of the High Court of Punjab and Haryana at Chandigarh in RFA Nos. 3836, 3415, 2509, 3433, 2510 3390, 2513, 3439, 2514, 3404/2013, 55, 4077/2014, 5425/2015, 4031/2014, 4224, 3436/2013, 3651/2014, 3831, 3402, 3832, 4398, 3428, 3829, 3432, 3382, 3835, 2542/2013, 2898/2014, 3430, 2540, 3408, 2539, 3834, 3384, 3424, 4018, 2515, 3391, 3837, 3405, 2508, 3438/2013, 5200/2014, 7295, 3839, 3422, 3443, 3828, 3410, 3838, 3419, 4105 and 4106/2013 alongwith application for permission to file Special Leave Petition.

It is further submitted that Counsel for petitioner

has also filed an applications for substitution of deceased petitioner no. 3 in RFA No. 3415/2013, 5 in RFA No. 3404/2013, 3 in RFA NO. 5425/2015, 4031/2014, 4 & 8 in RFA NO. 4031/2014, 2 in RFA NO. 3651/2014, 3831/2013, 2 in RFA Nos. 4398 & 3428/2013, Petitioner no. 1 in RFA No. (3430 & 2540/2013), (3424/2013), (2515 & 3391/2013), (3405/2013), (3410/2013), (3838/2013) and (3419/2013) which is barred by time by 1818, 3101, 251, 2915, 1537, 129, 109, 433, 1738, 38, 703,3446, 117 & 3187 days respectively and Counsel has also filed an application for condonation of delay in filing substitution application.

It is further submitted that Special Leave Petition filed against the Judgment and Order dated 06.10.2015 is barred by time by **155** days in RFA Nos. 3836, 3415, 3433, 3390, 3439, 3404/2013, 55, 4077, 4031/2014, 4224, 3436, 3428, 3834, 3384, 3424, 3391,3438/2013, 5200/2014, 3839, 3422, 3443, 3828, 3419/2013, **147** days in RFA Nos. 2509, 2510, 2513, 2514, , 2515, 2508/2013, **139** days in Rfa Nos. 5425/2015, 2542, 2540, 2539/2013, **150** days in RFA Nos. 3651, 2898, 3430, 3837, 3408, 3405/2013, **148** days in RFA Nos. 3831, 3402, 3832, 4018, 3410, 3838/2013, **130** days in RFA No. 4398/2013, **149** days in RFA Nos. 3829, 3432, 3382, 3835/2013, **134** in RFA No. 7295/2013, **153** days in RFA Nos. 4105 & 4106/2013 and Counsel for the petitioner has filed applications for condonation of delay in filing the SLP.

It is further submitted that SLP (C) No. 3661/2016 entitled Kohli Holdings Pvt. Ltd., Orient Craft Limited Vs State Of Haryana And Ors. arising out of common order was directed to be tagged with SLP (C) No. 3086-3135/2016 by the Hon'ble Court on 26.02.2016 (Copy of order dated 26.02.2016 is enclosed herewith). (Main matter SLP (C) Nos. 33902-33909/2014).

It is further submitted that Counsel for the petitioner has not furnished copies of notification/orders dated 17.09.2004, 27.10.2004, 27.04.2007, award dated 2.05.2004, 22.07.2003, 24.12.2013, 27.07.2005, 09.03.2006, 24.01.2007, 28.12.2007, 02.09.2013, 24.01.2007, 28.09.2013, 31.08.2013 and exhibits and award Nos. 892/2012, 341/2014, 1202 and 243/2009 mentioned in the impugned order as per his undertaking letter dated 22.06.2016. In this regard, Counsel has given a letter dated 12.07.2016 stating therein that the same are not available and not relevant for adjudication at present and has requested to list the matter at his risk.

The matter is, therefore, listed before the Hon'ble Court with this office report.
