pending after notice (Copy of order dated 27.01.2016 is enclosed herewith).

It is further submitted that Counsel for the petitioner has not furnished the copies of notification dated 07.03.2002 and 25.11.2002. In this regard, counsel has given a **letter** dated 02.05.2016 (Letter is enclosed in paper books at page no. 260) stating therein that the same are not relevant for adjudication of the case and has undertaken to produce the same at the time of hearing, if required by the Hon'ble Court and Counsel has requested to register and list the matter at his own risk.

The matter is listed before the Hon'ble Court with this office report.
