OFFICE REPORT

It is submitted that Dr. Kailash Chand, Advocate has filed Special Leave Petition on 19.02.2016 against the Judgment and Order dated 06.10.2015 of the High Court of Punjab and Haryana at Chandigarh in RFA Nos. 4355/2010 and Cross Objection NO. 182-CI of 2010 in RFA No. 4355/2010. 4350/2010 and Cross Objection NO. 186-CI of 2010 in RFA No. 4350/2010, 3191, 4491,3105/2011, 3504/2010 and Cross Objection NO. 15-CI of 2011 in RFA No. 3504/2010, 5953, 6256, 6272, 6737/2011, 4220/2010, 3187, 4061, 3512/2010, 3160/2010 and Cross Objection NO.

It is further submitted that Counsel for the petitioner has filed two applications for condonation of delay in filing the SLP and refiling the SLP (i) there is a delay of 41 days in filing the SLP (ii) a delay of 58 days in refiling the SLP. There is a total delay of 99 days in filing and refiling the SLP.

It is further submitted that the instant matter is tagged with SLP (C) CC No. 9211 of 2016 Entitled Rati Ram And Ors. Versus Haryana State Indus. & Infrastr. Dev. Corp. Ltd. And Ors as both are arising out of common relied upon order.

It is further submitted that Counsel for the petitioner has not furnished copies of order dated 07.02.2002, 25.11.2002, 06.03.2002, 26.06.2002, 15.11.2002, 11.02.2006, 06.10.2008, 27.01.2010, 20.05.2004, 22.07.2003, 24.12.2003, 27.07.2006, 09.03.2006, 24.01.2007, 28.12.2007, 07.07.2011 and exhibits mentioned in the impugned order as per his

undertaking letter dated 16.05.2016. In this regard, Counsel has given a letter dated 02.06.2016 stating therein that the same are not available and not relevant for the adjudication. Counsel has also requested to list the matter as it is at his risk.

The matter is, therefore, listed before the Hon'ble Court with this office report.
