It is submitted that Dr. Kailash Chand, Advocate has filed Special Leave Petition on 28.10.2016 against the Judgment and Order dated 6.10.2015 of the High Court of Punjab and Haryana at Chandigarh in RFA Nos.6369 of 2013, 8186 of 2014, 4400 of 2014, 4038 of 2014, 1273 of 2014, 4020 of 2014, 4052 of 2014, Cross objection No. 65-CI of 2015 in RFA No. 4052 of 2014, 7115 of 2013, 4424 of 2013, 3734 of 2014, 4043 of 2014, 4009 of 2014 and cross objection NO. 63-CI of 2014 in RFA NO. 4009 of 2014, 1817 of 2014, 2067 of 2014, 5321 of 2014, 4027 of 2014, 2071 of 2014, 1818 of 2014, 2070 of 2014, 1819 of 2014, 2076 of 2014, 2073 of 2014, 2266 of 2014, 4044 of 2014, 7275 of 2013, 5198 of 2014 and cross objection No. 69-CI of

2014 in RFA No. 5198 of 2014, 1508 of 2014 and 2072 of 2014 alongwith application for permission to file Special Leave Petition.

It is further submitted that Counsel for petitioner has also filed an application for substitution to bring on record the Lrs. of deceased petitioner No. 4 viz. Charni @ Charan Singh in RFA No. 4400/2014 and petitioner No. 3 in RFA No. 4038/2014, petitioner No. 18 viz. Gagan Singh in RFA NO. 4400/2014, petitioner NO. 17 in RFA No. 4038/2014 and RFA No. 4009/2014, petitioner No. 1 viz. Gajraj in RFA NO. 4038/2014, petitioner No. 1 viz. Mahabir in RFA NO. 4052/2014, petitioner viz. Ishwar @ Ishar in RFA No. 7115/2014 and RFA No. 4424/2013, petitioner No. 9 viz. Amar Bai in RFA NO. 4009/2014, petitioner No. 14 viz. Bhagwati in RFA No. 4009/2014, petitioner No. 1 viz. Bijay Singh @ Vijay Singh in RFA No. 2067/2014, petitioner No.1 viz. Gabbu Singh in RFA NO. 1817/2014, petitioner No. 4 viz. Naurang Pal in RFA No. 5321/2014 and petitioner No. 4 in RFA NO. 4027/2014, petitioner No. 5 viz. Bhanwar Pal in RFA No. 4027/2014, petitioner No. 3 viz. Karan Singh in RFA No. 2071/2014 & petitioner No. 2 in RFA NO. 2070 of 2014, petitioner No. 8 viz. Man Singh in RFA No.2076/2014, petitioner NO. 2 viz. Agar Devi in RFA No. 2073/2014 which is barred by time by 297, 543, 3941, 366, 946, 316, 1807, 1767, 197, 1340, 1890, 940, 2897, 2111 days and Counsel has also filed an application for condonation of delay in filing substitution application with prayer for setting aside abatement.

It is further submitted that Special Leave Petition filed against the Judgment and Order dated 6.10.2015 is barred by time by 294 days in RFA Nos. 1818 and RFA No. 4038 of 2014, 278 days in RFA No.2073 of

2014, 298 days in RFA Nos. 6369 of 2013, RFA nos. 4400, 7115, 4424, 3734, 4043, 2076, 226, 4044, 7275, 5198, 1508, 2072 of 2014, 279 days in RFA NO. 8186 of 2014, 294 days in RFA No. 1273/2014, 290 days in RFA No. 4052/2014, 270 days in RFA No. 4009 of 2014, 291 days in RFA No. 4020 of 2014, 290 days in RFA NO. 1817 and 2067 of 2014, 294 days in RFA No. 2071 of 2014, 295 days in RFA NO. 5321 and 4027 of 2014, 294 days in RFA NO. 2070 and 1819 of 2014 and Counsel for the petitioner has filed an application for condonation of delay in filing the SLP.

It is further submitted that SLP (C)...CC No.25201/2016 Entitled DHARAMENDER AND OTHERS Versus STATE OF HARYANA AND OTHERS as both are arising out of common order was listed before the Hon'ble Court on 6.1.2017 and directed to be heard along with SLP (C) No. 33902-33909/2014, SLP (C) No. 3086-3135/2016.(Copy of order dated 6.1.2017 enclosed herewith).

It is further submitted that the SLP (C) No.3661/2016 Entitled Kohli Holdings Pvt. Ltd. Orient Craft Ltd. Versus State of Haryana and Ors. as both are arising out of common order is listed before the Hon'ble Court on 26.2.2016 and the court directed to tag with SLP (C) No. 3086-3135 of 2016. (Main SLP (C) No. 3086-3135/2016).

It is further submitted that Dr. Kailash Chand, Counsel for the petitioner has on 19.1.2017 filed a letter stating therein that Award/order dated 20.2.2014, 24.1.2007, 10.11.2012, 28.9.2013, 27.8.2013, 17.8.2013, Notification dated 27.9.2005, 2.6.2006, 24.11.2006 and exhibits mentioned in the impugned order is not available and same are not relevant to the adjudication at present and counsel has requested to register and list the matter

at his own risk.

The matter is listed before the Hon'ble Court with this office report.
