**ORDER**

1. This Transfer Petition purported to have been filed under Article 139A(2) of the Constitution of India read with Section 25 of the Code of Civil Procedure (for short, 'the Code') is with a prayer that the Trade Mark Suit No. 12 of 2023 titled as "*Innovative Healthcare Vs Innovative Healthcare (India) Pvt.
