OFFICE REPORT

The matters above mentioned alongwith connected matters were listed before the Hon'ble Court on 17.12.2014 when the Court was pleased to pass the following Order:

SLP No. 1672/2014

There are 66 respondents in the matter. Show cause notice was issued to all the respondents on 27.02.2014 by registered A.D. Post. Neither A.D. cards nor unserved cover have been received back from all the respondents so far.

Service of show cause notice is not complete on all the respondents.

SLP No. 1674/2014

There are 6 respondents in the matter. Show cause notice was issued to all the respondents on 27.02.2014 by registered A.D. Post. Mr. S.M. Garg, Advocate has filed vakalatnama & memo of appearance on behalf of respondent nos. 2 & 4, but has not filed counter affidavit on their behalf.

Service of show cause notice is not complete on respondent Nos. 1, 3, 5 & 6 so far.

SLP No. 62/2014

There are 19 respondents in the matter. Show cause notice was issued to all the respondents on 27.02.2014 by registered A.D. Post. Mr. M.R. Shamshad, Advocate has filed vakalatnama & memo of appearance and counter affidavit on behalf of respondent nos. 1 to 4.

Service of show cause notice is not complete on respondent Nos. 5 to 19.

SLP Nos. 11673/2014

There are 63 respondents in the matter.

It is submitted that Counsel for the Petitioner has filed application for exemption from filing Process Fees etc. instead of filing Process Fees and spare copies of SLP. Hence, show cause notice could not be issued to all the 63 respondents in SLP No. 11673/2014.

SLP Nos. 11671/2014

There are 5 respondents in the matter. Show cause notice was issued to all the 5 respondents by registered A.D. post on 30.06.2014 as well as dasti on 27.10.2014 vide Ld. Registrar's order dated 18.10.2014. Counsel for the Petitioner has not filed Affidavit of Dasti service. Service of show cause notice is not complete on all the respondents.

SLP No. CC: 10408/2014

The matters above mentioned were listed before the Hon'ble Court on 18.07.2014 when the following Order was passed:

“Tag with C.A. Nos. 4347-4375/2014.”

It is submitted that the Competent Authority has not filed the compliance report in pursuance of the above said orders dated 17.12.2014.

As the connected matter is on board, hence this report.
