It is submitted that the above mentioned Special Leave Petition is filed by Mr. Ranbir Singh Yadav, Advocate on 02.01.2016 against the Judgment and Order dated 16.09.2015 of the High Court of Punjab and Haryana at Chandigarh in RFA Nos. 4377, 5227, 5228, 5229, 5230, 5231, 5232, 5233, 5234, 5235, 5236, 5237 and 7209 of 2013 (O & M) alongwith application for permission to file Special Leave Petition.

It is further submitted that **notice** in SLP (C) No.2651 of 2016 Entitled Sushila Rani & Anr. Versus State of Haryana & Anr. arising out of common Order was directed on 05.02.2016 by Hon'ble Court. SLP is pending after notice (Copy of order dated 05.02.2016 is enclosed herewith).

It is further submitted that Counsel for the petitioner has on 26.07.2016 filed additional documents as per his undertaking letter dated 02.02.2016 and the same are being circulated before the Hon'ble Court.
